1. Designation of processing activity

3. Purpose and legal basis for the processing of data

Your data will be collected to record you as a member, to communicate with you, to invite you to our events, to send you our newsletter and our member magazine and other information and to send you surveys to further develop our membership offer.

Your data will be processed on the basis of Art. 6 Sec. 1 (1) lit. b GDPR in conjunction with our statutes.

4. Recipients or categories of recipients of personal data

In addition, our commissioned IT service providers, which i.a. provide our member database software and support us on technical issues, have access to your personal data. The purpose of this is the secure and professional processing of member data on a database for effective execution of the contract with you.

The list of processors and data controllers is kept at the headquarters of the persons responsible.

5. Forwarding of personal data to a third country

It is planned to process your personal data both in India and in Germany, in order to be able to carry out the contract with you as best as possible, cf. Art. 49 Sec. 1 (1) lit. b and lit. c GDPR.

If we intend to disclose your information to third parties, including third parties outside of our organization, such as embassies, trade show partners or external experts, we will not do so without your consent. In individual cases, we will collect these separately from you.

6. Duration of storage of the personal data

Your data will be stored after the survey for the duration of your membership. Legal retention periods may also require storage beyond that.

7. Rights of the data subject

You have the following rights according to the EU General Data Protection Regulation:

If your personal data is processed, you have the right to obtain information regarding the storage of your personal data (Section 15 GDPR).

If incorrect personal data is processed, you have the right to correction of such (Section 16 GDPR).

If legal requirements are given, you have the right to request the deletion or limitation of processing, and you have the right to object to such processing (Sections 17, 18 and 21 GDPR).

In case of an objection, we can no longer reach you as a member, and the membership relationship would end.

If you have given your consent to data processing or if a contract exists pertaining to data processing and if such data processing is carried out via automated processes, you have a right to data portability where applicable (Section 20 GDPR).

Should you exercise your above-mentioned rights, the AHK Indien (IGCC) will review whether statutory requirements are met.
